- I. Call the Meeting to Order – District Managing Committee Chair --- James Shada, Arlington. **Meeting was called to order by James Shada, Arlington**

Melissa Waylee spoke about adding Lacrosse as a NSAA sport. Her experience was in Tennessee and she was instrumental in getting that approved as a sanctioned sport. There are 26 states that have sanctioned Lacrosse. Talked to Jennifer Schwartz at the NSAA office about Nebraska's process of adding Lacrosse as a sport. Melissa has a daughter at Westside High School. She stated that in District II this is over a 1,000 athletes competing in Lacrosse. Talked about college opportunities and scholarships. Great environment. She was there to talk about the benefits of Lacrosse and would like a proposal submitted by next October 2024.
- Nathan Simmons talked about the importance of Esports and adding it to the NSAA as an sanctioned activity. Talked about kids that involved in Esports are not involved in many activities at school.
There are over 100 teams in the state. There are a lot of connections with the state colleges in Nebraska. Many students that have been involved in Esports have received college scholarships. Want to have a more relevant experience in high school.
